

SCHOLARSHIPS FROM THE GOVT.

(A student is eligible for only one scholarship in one course)

National Scholarship (Check website www.momasscholarship.gov.in)

1. **Merit – cum-Means Scholarship** for Professional and Technical courses (mcm or moma)
MOMA scholarships are minority scholarships initiated by the Ministry of Minority Affairs. Under the MOMA scholarship scheme, students belonging to the minority communities of Muslim, Sikh, Christian, Buddhist, Jain and Zoroastrian (Parsi) can avail Pre-matric scholarships, the scholarship amount is Rs. 20,000/ per annum. The annual family income must be under 2.5 lakhs. For details

E-Grantz scholarship (Check website www.e-grantz.kerala.gov.in)

1. Kerala domiciled students can only apply.
2. Eligible categories are SC, ST, OEC (another eligible cast), OBC, OBC(H), General communities.
3. For SC, ST and OEC, OBC (H) there is no income limit for scholarships. For OBC and general communities, the annual family income must be less than one lakh.
4. The applicant must have more than 75% of attendance each month
5. Applicants must not receive any other scholarships
6. During course time free Laptop and stethoscope are eligible for sc and st students (for sc it is in first year during course and for st it is in second year)

Minority Welfare Scholarships:

1. **CH Muhammed Koya Scholarship (CHMS)** – Scholarship amount: Rs. 7000/ year and Rs. 13000/ year for hostel fee.
Eligibility conditions. 1. Must be a Keralite and should belong to Muslim, Latin, converted Christian community. 2. Only girl students are eligible for this scholarship and family income must be below 8 lakhs. 3. Those who are eligible for a hostel stipend are not eligible for the scholarship.
2. **Mother Theresa Scholarship** – Scholarship amount 15,000/ year. 1. Should be a Keralite and family income must be under 8 lakhs. 2. Should belong to Muslim, Christian, Sikh, Buddha, Parsis, Jains community.
3. **Dr. APJ Abdul Kalam Scholarship** - Scholarship amount Rs. 6,000/ year. 1. Should belong to Muslim, Christian, Sikh, Buddha, Parsis, Jain community. 2. Family income must be under 8 lakhs and must be a Keralite.
4. **Indira Gandhi Scholarship**- for single girl child for PG programmes – Amount of fellowship: Rs. 36,200/- per annum. 1. Applicant must be single girl child in the family. 2. Must be under the age of 30.
5. **Prof. Joseph Mondassery Scholarship** – Scholarship amount Rs. 15000/- 1. Should belong to Muslim, Christian, Sikh, Buddha, Parsis, Jain community. 2. Family – annual income should not exceed 8 Lakhs. 3. Should be native to Kerala
6. **Ishan Udaya** (Special scholarship for northeast students) – Scholarship amount Rs. 7800/- per month. 1. Should be a domicile of Northeast and annual income must be under 4.5l.

(Deliverables: For students pursuing post-matric courses approved by the University / Board)

Scheduled Caste and Scheduled Tribe community:

- Lumpsum grant, Monthly stipend (day scholars); ABLC + Pocket Money (hostellers)
- These students do not have to pay Tuition Fee, Special fee and Examination fee

OBC- For PG and Professional courses:

- Lumpsum grant, monthly stipend, Tuition fee has to be paid in full.
- Reimbursement of tuition fee, special fee and exam fee subject to income limit
- Fee is sanctioned once in an Academic year and paid to institution's Account.
- LSG is sanctioned once in a year, stipend and mess charges are sanctioned and credited to student's bank Account.
